Mihaela TOFAN (b. 1976, Iași) is a university professor at Alexandru Ioan Cuza University of Iași, Faculty of Economics and Business Administration, CSI within the Acad. Andrei Rădulescu Institute of Legal Research of the Romanian Academy and active lawyer. She holds a degree in legal sciences from the Faculty of Law of Alexandru Ioan Cuza University of Iași (1999) and a doctorate in legal sciences from the Faculty of Law of the University of Bucharest (2008), a qualified doctorate in administrative sciences from Babeș Bolyai University (2019) and a qualified doctorate in legal sciences from the Bucharest Academy of Economic Studies (2023). She is Jean Monnet Professor (2010) and Director of the Jean Monnet Chair European Financial Regulation EUFIRE (www.EUFIRE.uaic.ro), coordinator of the Centre of Excellence European Financial Resilience and Regulation in the European Union (2022), within the Alexandru Ioan Cuza University of Iași, ERASMUS Professor at numerous universities in the EU and beyond. She is Fulbright Visiting Professor Alumna at NYU (2019) and Fordham University (2024), author and co-author of 20 specialized volumes and over 100 articles published in volumes and journals indexed in international databases. Her area of interest is EU Law, Tax Harmonization and European Law, and Business Law.

Irina BILAN (b. 1980, Iași) is associate professor Ph.D. at Alexandru Ioan Cuza University of Iași, and associate professor at Hassan II University of Casablanca (Morocco). Her areas of expertise include public finance, international finance, money and banking, and social security systems. She carried out research and documentation visits at Paris Dauphine University (France, 2010), the University of Poitiers (France, 2015), the University of Bolton (UK, 2018), the University of Zaragoza (Spain, 2018), and the University of Michigan-Flint (USA, 2019), and has taught within the Erasmus programme in Italy, Turkey, Kazakhstan, Belgium, Spain, Morocco, Egypt, Croatia, Vietnam, Uruguay, etc. She attended advanced training programmes on topics such as “Management of Tertiary Activities” (2011), “SAP, ERP and School Management” (2011–2012), “Didactics of Teaching Humanities” (2012), and “Panel Data Econometrics” (2018). She coordinated the Jean Monnet Module EUCONOMICS (2020–2023), participated in several other Erasmus+ programmes, and published as author or co-author a book, several book chapters, and more than 70 papers in journals indexed in international databases or conference proceedings. In addition to her academic roles, she is a private researcher for AFIN IFN, where she contributes to the creation of a social investment fund in Romania.

Elena SUMAN (b. 1984, Iași) is assistant professor Ph.D. at the Department of Finance, Money and Public Administration within Alexandru Ioan Cuza University of Iași. She has published, as author or co-author, over 20 articles in journals indexed in international databases, as well as in the proceedings of national and international conferences.
